<ul style="list-style-type: none"> <li>Homes Now! to operate</li> </ul>	<ul style="list-style-type: none"> <li>Coop should operate</li> </ul>	<p>Apply for RFQ – get ducks in row for Spring – you will be fairly considered</p>
<ul style="list-style-type: none"> <li>City to permit post haste</li> </ul>	<ul style="list-style-type: none"> <li>Why do we need permits? People can die.</li> </ul>	<p>We issue permits within 30 days on encampments. Public has a right to comment.</p>
